AMENDMENT TO DECLARATION

This Amendment to Declaration is effective as of the 1st day of April, 1983.

RECITALS

A. AMERICAN PLAZA TOWERS is a condominium in the City of Portland, County of Multnomah, State of Oregon, which was established by that certain Declaration for American Plaza Towers recorded October 4, 1972 in Book 886, page 13, Deed Records, and supplemented and restated by that certain Supplemental Restated Declaration recorded December 30, 1974 in Book 1021, page 2042, Deed Records, as amended by instrument recorded May 29, 1975 in Book 1043, page 373, Deed Records, and as further amended by instrument recorded August 20, 1976, in Book 1122, page 1424, Deed Records as further amended by instrument recorded June 6, 1979 in Book 1357, page 880, as further amended by instrument recorded February 27, 1981 in Book 1506, page 849, as amended by Correction of Second Supplemental Declaration for American Plaza Towers (Phase III), recorded March 11, 1981 in Book 1508, page 1813, as amended by Amendment to Second Supplemental Declaration recorded November 10, 1981 in Book 1561, page 1141, Deed Records. The original Declaration, as amended, is hereinafter referred to as "the Declaration."

B. The Declaration names J. Eugene Popma of Portland, Oregon as the person who is to receive service of process in cases provided in ORS 94.280(1).

C. The sole purpose of this Amendment is to designate a new person to receive service as permitted by ORS 94.280(2).

NOW, THEREFORE, the undersigned, as Chairman and Secretary of the Association of unit owners of American Plaza Towers hereby certify that the following amendment to Article (18) of the Supplemental Restated Declaration, which is incorporated by reference in and to the Second Supplemental Declaration for American Plaza Towers (Phase III), has been approved by a vote of ninety percent (90%) of the unit owners:

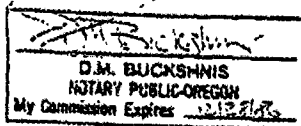
